According to Art. 13 sec. 1 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (General Data Protection Regulation) (Journal of Laws UE L of May 4, 2016 No. 119 p. 1), hereinafter referred to as GDPR, we would like to inform you that

- 1. The Data controller of your personal data (hereinafter "personal data") is Sieradzki Klub Karate Kyokushinkai with its registered office in Sieradz, ul. - 2. Personal data of participants of classes, including minors, are processed in order to perform the tasks resulting from the Statute of the Sieradz Karate Club Kyokushinkai, including the organization and conducting classes of the Sieradzki Karate Kyokushinkai Club.
- 3. The legal basis for the processing of your personal data is Art. 6 sec. 1 lit. a Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC, i.e. the person whose data regarding consent to the processing of their personal data for one or more specific purposes.
- 4. Providing personal data for the purpose of carrying out the tasks resulting from the Statute of the Sieradzki Karate Kyokushinkai Club, including the organization and conducting classes of the Sieradz Kyokushinkai Karate Club, is voluntary. Failure to consent to the processing of data will result in the inability to participate in organized classes and exercise the rights resulting from the statute.
- 5. The consent may be withdrawn at any time, with the proviso that the withdrawal of consent will not affect the lawfulness of data processing prior to the withdrawal of consent.
- 6. The basis for data processing to the extent necessary for the purposes of the legitimate interests pursued by the administrator or by a third party may also be art. 6 sec. 1 lit. f GDPR.
- 7. Personal data of participants in sports competitions are processed in order to organize and conduct sports competitions. The indicated personal data are processed on the basis of consent granted in accordance with art. 6 sec. 1 lit. a GDPR.
